

# Board Meeting Minutes November 18th, 2021

Noting quorum of the board, the meeting was called to order by Russ Simpkins at 7:36 p.m.

# **Open Comment**

- Residents raised concern over the state of the split wooden railing throughout the neighborhood. The board will look at power washing and repairing these in the Spring.
- Stop signs need general maintenance throughout the neighborhood. Dave volunteered to get a quote.
- General discussion on the speedbump proposal. Research continues, a homeowner suggested not wasting time on solutions less permanent than anchoring bumps into the street foundation. He has seen other options fail and they are quite expensive. Dave continues to lead the effort and is expecting to have a full proposal ready for the board by the Spring.
- Project plans discussed for Gazebo and Bike rack projects (Notice and Comment mailed in annual packet)

- David motioned to replace the removed gazebo with the pergola option from the notice & comment, Eddy seconded the motion. The board voted as follows: Anthony: yes, Brian:yes, David:yes, Eddy:yes, Jonathan:no, Russ: no, Veerat:no. Motion carried and the board approved the pergola replacement.
- David motioned to install the small 8 bike rack from the notice & comment, Brian seconded the motion. The board voted as follows: Anthony: yes, Brian:yes, David:yes, Eddy:yes, Jonathan:yes, Russ: yes, Veerat:yes. The board approved the bike rack project.

#### **Board Elections**

- Three of the Board positions were up for election this year. Each member serves a 2 year term.
